

# Forestry and Land Management (Scotland) Act 2018

## Notice of Liability for Expenses

Scottish Forestry, on behalf of Scottish Ministers, gives the following Notice of Liability for Expenses under section 64 of the Forestry and Land Management (Scotland) Act 2018 ("the Act").

### Background

This Notice of Liability for Expenses ("the Notice") is given further to the action taken by Scottish Forestry on behalf of the Scottish Ministers pursuant to Section 59 of the Act between the dates of [*insert date*] and [*insert date*].

Under section 59 of the Act Scottish Forestry carried out all works and complied with all conditions as set out in the [Remedial Notice / Registered Remedial Notice] referenced [*insert ref.*], a copy of which is annexed and signed as relative to this Notice.

### Land to which the Notice relates

The effect of the Notice is that each owner of the Land is jointly and severally liable for the expenses and interest mentioned in this section of the Notice.

Once [registered / recorded] against the Land in the [Land Register of Scotland OR General Register of Sasines] the registered notice of liability for expenses will be shown in legal reports instructed over the Land. An owner of the land who is liable for the expenses and interest in this Notice does not cease to be liable for the expenses and interest by virtue only of ceasing to be the owner of the land.

#### **Recovery of Expenses from a New Owner of the Land**

Where this Notice is registered in relation to the land and the notice was registered at least 14 days before the date on which a person ("the New Owner") acquires right to the land, the New Owner is severally liable with any former owner of the land for any expenses and interest in the Notice.

Where a New Owner pays any expenses and interest for which a former owner of the land is liable, the New Owner may recover the amount so paid from the former owner, and does not cease to be entitled to recover the amount so paid by virtue only of ceasing to be the owner of the land.
