

Forestry and Land Management (Scotland) Act 2018

Notice to Comply

Scottish Forestry, on behalf of Scottish Ministers, gives the following Notice to Comply under section 38 of the Forestry and Land Management (Scotland) Act 2018 ("the Act").

Background

This Notice to Comply is given further to the continuing condition(s) ("the Condition(s)") set out in Part 2 of the Felling Permission granted by Scottish Forestry on behalf of the Scottish Ministers pursuant to Section 27 of the Act, dated [*insert date*], under reference [*insert ref.*], a copy of which Felling Permission is annexed and signed as relative to this notice ("the Felling Permission").

OR

This Notice to Comply is given further to the Felling Direction given by Scottish Forestry on behalf of the Scottish Ministers pursuant to Section 34 of the Act, dated [*insert date*], under reference [*insert ref.*], a copy of which Felling Direction is annexed and signed as relative to this notice ("the Direction").

OR

This Notice to Comply is given further to the Restocking Direction given by Scottish Forestry on behalf of the Scottish Ministers pursuant to Section 36 of the Act, dated [*insert date*], under reference [*insert ref.*], a copy of which Restocking Direction is annexed and signed as relative to this notice ("the Direction").

Land to which the [Condition(s) / Direction] relates

Section 28 of the Act on the part of the person granted the Felling Permission.

OR

The effect of the Direction is that the owner of the Land is obliged to carry out all works and comply with all conditions as set out in the Direction, to the satisfaction of Scottish Forestry. Failure to comply with the Direction is a criminal offence under Section 35 of the Act on the part of the person to whom the Direction is given.

OR

The effect of the Direction is that the owner of the Land is obliged to carry out all works and comply with all conditions as set out in the Direction, to the satisfaction of Scottish Forestry. Failure to comply with the Direction is a criminal offence under Section 37 of the Act on the part of the person to whom the Direction is given.

Once [registered / recorded] against the Land in the [Land Register of Scotland OR General Register of Sasines] the registered notice to comply will be shown in legal reports instructed over the Land. Further, failure to comply with a registered notice to comply is a criminal offence under Section 39 of the Act on the part of the Owner of the Land.

INSERT PLAN

Ensure:

- Plan must be on OS Mastermap base layer
