

Forestry and Land Management (Scotland) Act 2018

Notice of Variation

Scottish Forestry, on behalf of Scottish Ministers, gives the following Notice to Variation under section 40 of the Forestry and Land Management (Scotland) Act 2018 ("the Act").

Background

This Notice of Variation relates to the Notice to Comply by Scottish Forestry on behalf of the Scottish Ministers pursuant to Section 38 of the Act, registered in the Land Register of Scotland on [*insert date*], and varies the Notice to Comply from the date of registration of this Notice of Variation.

This Notice to Variation relates to the Registered Remedial Notice by Scottish Forestry on behalf of the Scottish Ministers pursuant to Section 56 of the Act, registered in the Land Register of Scotland on [*insert date*], and varies the Registered Remedial Notice from the date of registration of this Notice of Variation.
